WORKING COMMITTEE ACTIVITIES



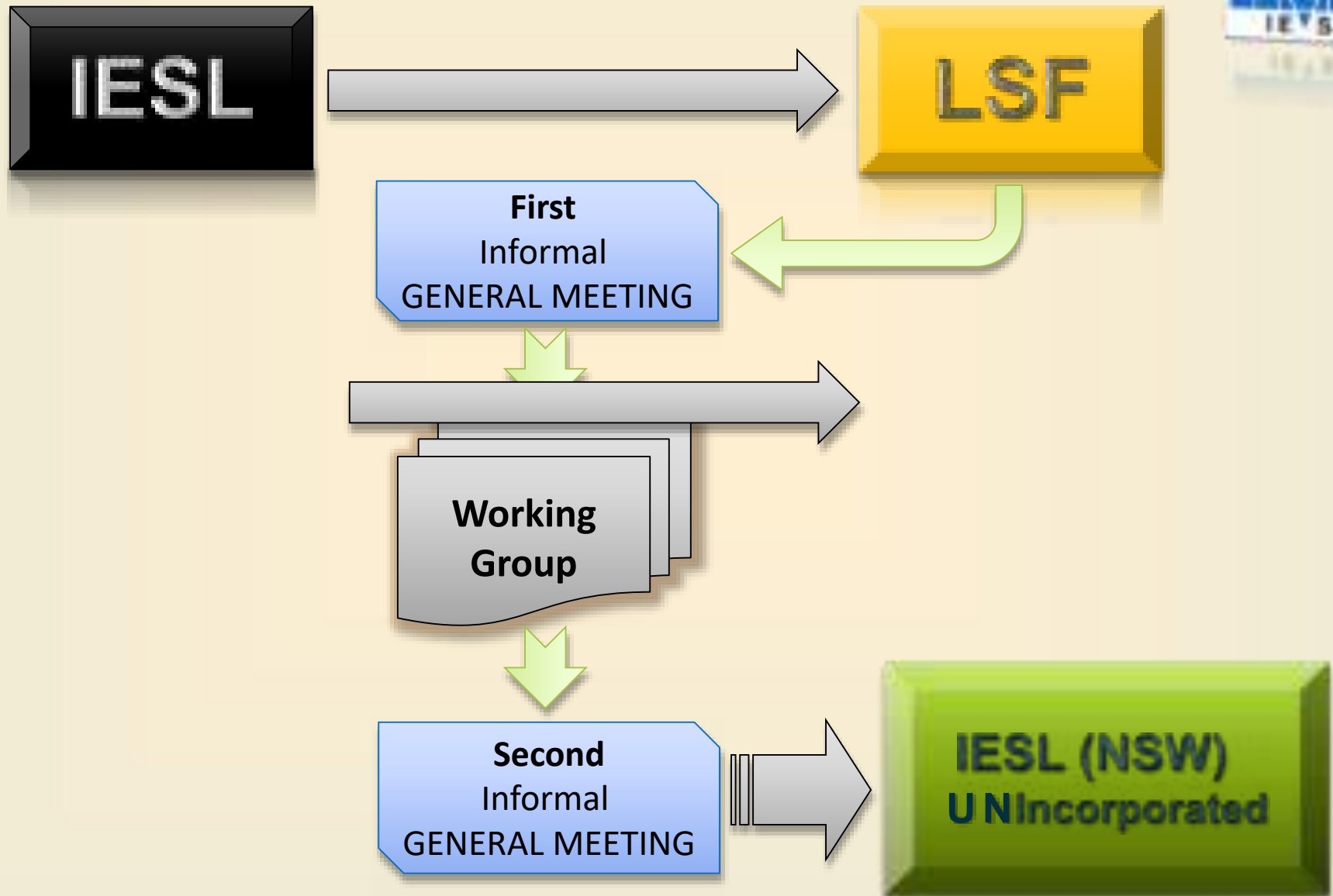
- *Working Committee met 4 times*

ORGANISATIONAL

ADMINISTRATIVE

- *Hold Committee meetings, AGM, SGMs as per the constitution*
- *Maintain a Chapter membership register*
- *Channel relevant IESL correspondence to the Chapter membership*
- *Liaise with IESL on behalf of Chapter membership*

FINANCIAL

- *Collect and disburse funds*
- *Keep financial activity records*
- *Raise funds through appropriate means*

PROFESSIONAL DEVELOPMENT

- *Form Learned Groups to promote and advance the science and practice of engineering*
- *Arrange Seminars etc, on topical technical subjects*
